Hospital Type Definitions

BASE: Base hospital - medical direction provided to prehospital personnel by MICNs, in consultation with ED MD/DO when necessary

MOD: Modified base hospital - medical direction provided directly by ED MD/DO when necessary

REC: Receiving hospital - unable to provide any medical direction to prehospital personnel, but able to receive ambulance patients
