THE POSITION

The **Emergency Medical Services Agency** is seeking a dynamic, energetic and motivated candidate to fill the Regional Disaster Medical Health Specialist (RDMHS) position. This is a full-time position in which the incumbent reports to the Associate Director (North Counties), and carries out administrative, analytical, and oversight activities to ensure that the Scope of Work, developed annually by the EMS Authority, is fully addressed. The primary areas of responsibility of this position are described in the attached Scope of Work, but are subject to modification annually by the EMS Authority.
