PURPOSE:

To establish the AED provider approval process and ongoing requirements of an S-SV EMS approved AED provider.

AUTHORITY:

- A. California Health and Safety Code, Division 2.5.
- B. California Code of Regulations, Title 22, Division 9, Chapters 1.5 and 2.

DEFINITIONS:

Automated External Defibrillator (AED) – An external defibrillator capable of cardiac rhythm analysis that will charge and deliver a shock, either automatically or by user interaction, after electronically detecting and assessing ventricular fibrillation or rapid ventricular tachycardia.

AED Provider – An organization that employs Public Safety First Aid (PSFA), Emergency Medical Responder (EMR) and/or Emergency Medical Technician (EMT) personnel, and who obtains AEDs for the purpose of providing AED services to the general public.

POLICY:

An AED provider shall be approved by S-SV EMS and continually meet all requirements set forth by State law, regulations and S-SV EMS policies. AED provider approval may be revoked or suspended for failure to comply with the requirements of this policy.

PROCEDURE:

- A. AED Provider Approval Process:
 - 1. An EMS prehospital service provider desiring to provide AED services to the general public shall submit a written request to S-SV EMS for approval to provide such services. The written request shall include the following:
 - Organization name, address and contact information.
 - A description of the number, type, and location of AEDs that will be utilized.

- A description of the organization's AED equipment orientation training for PSFA, EMR and/or EMT personnel.
- A description of the organization's AED equipment maintenance program.
- A description of the organization's procedures for collection and retention of AED utilization medical records.
- A description of the organization's quality improvement (QI) monitoring and oversight processes related to AED utilization.
- 2. Program approval or disapproval shall be made by S-SV EMS within thirty (30) calendar days after receipt of all required documentation listed in this section.
- B. Approved AED Provider Requirements:

An S-SV EMS approved AED provider shall continually comply with the following:

- Maintain a listing of all AED authorized PSFA, EMR and EMT personnel, and provide this information to S-SV EMS upon request.
- 2. Notify S-SV EMS by the end of the next business day of any AED equipment malfunction or inappropriate application/use of an AED.
- Collect and submit the following information as part of the EMS prehospital service provider's Emergency Medical Services Quality Improvement Program (EMSQIP) annual report:
 - The number of patients with sudden cardiac arrest receiving CPR prior to arrival of emergency medical care.
 - The number of patients on whom defibrillatory shocks were administered.
 - A summary of QI issues or concerns related to the organizations AED program.
 - Any additional AED provider data deemed necessary by S-SV EMS.
