### **S-SV EMS EMT/AEMT Recertification Application Process**

- Go to [www.ssvems.com](http://www.ssvems.com), click on the 'Application Center' link in the top ribbon and scroll down to the 'EMT/AEMT Recertification' box. Click on the 'Recertification Application' link and enter the appropriate information to complete the application (the application is **NOT** printable).
- **All applicants** must attach to the online application or submit copies of the following:
  - Current U.S. state-issued Driver's License or photo ID.
  - Current or expired EMT certification card.
  - Proof of required Continuing Education (CE) from a California or CAPCE approved EMS CE provider (CE documentation form):
    - EMT recertification - Minimum of 24 hours of CE or completion of a 24 hour EMT refresher course.
    - Renewal of a lapsed certification may require additional CE's:
      - Lapsed 0-6 months- 24 CE's
      - Lapsed 6-12 months- 36 CE's
      - Lapsed 12+ months- 48 CE's, NREMT card, plus a new Live Scan
  - A completed EMT Skills Verification Form (01/2017 version - only original ink version; paper, pdf, or picture).
- Pay the certification fee online (Select the "Add to Cart" button at the bottom of the confirmation page), or in person, with a debit/credit card. The \$86.00 fee is non-refundable (includes a \$4.00 electronic processing fee), or \$82.00 if paying with a Money Order (made out to the S-SV EMS Agency).
  - Note: Applicants that are lapsed 12+ months are required to pay the initial certification fee of \$124.00 (includes a \$4.00 electronic processing fee), or \$120.00 if paying with a Money Order (made out to the S-SV EMS Agency).
